

# ATHLETE'S AGREEMENT

## 1. Governing Body

- i. The "Athlete" acknowledges that Singapore Silat Federation (SSF) is the sole governing body for the sports of Pencak Silat in Singapore and that Singapore Silat Federation is recognized by the Asian Pencak Silat Federation (APSIF), International Federation (PERSILAT), Sports Singapore (SportSG), Sports Singapore Institute (SSI) & National Youth Sports Institute (NYSI).

## 3. Trainings & Events Attendance

- Athlete to attend minimum 85% of training sessions monthly located at respective SSF training locations: OCBC Arena & Heartbeat@Bedok

- Athlete to attend minimum 85% of events or functions monthly that is being held by SSF, SSI / NYSI

- To provide MC or supporting documents if athlete is unable to attend for training or SSF events. Absence without MC or supporting document will affect overall monthly attendance

- For athletes training at OCBC Arena, he / she is required to scan his / her thumbprint for attendance. For athletes training at Heartbeat@Bedok, attendance will be taken before the start of every training session. For athletes training at SSP, attendance will be taken by Sports Manager
- Athlete attendance report will be submitted to parents via mail. To ensure that parents are aware of their child whereabouts and records.

#### 4. Competition Selection

- For international competition, athlete will be selected based on attendance, code of conduct and training feedbacks from coaches

- For multi - event games (SEA Games, Asian Games, Asian Beach Games), only athlete with prominent international achievements based on SNOC requirement will be shortlisted to SNOC for final decision

- Athlete should take note that their position in the team may change at any point failure to meet minimum requirement

#### 5. Code of Conduct

- Athlete caught smoking or possession of cigarettes during training, competition or at any sports related events will be suspended from training & competition for 6 months. For underage smoker (born after 2000) will be referred to relevant authorities

- Athlete caught consuming, smuggling or possession of drugs will be handed over to Central Narcotics Bureau (CNB) and will be suspended or expelled from SSF National Team, pending the outcome of their Investigation.

- Athlete caught consuming or possession of alcohols during training, competition or at any sports related events will be referred to the MC and will be suspended or expelled from SSF National Team pending the outcome of MC's decision

- Athlete caught stealing will be handed over to the Police and will be suspended or expelled from SSF National Team, pending the outcome of the Police Investigation.

- Athlete caught in act sexual assault and disrespecting opposite gender will be referred to the Police and MC respectively for Investigation purpose. Meanwhile, the Athlete involved will be suspended or expelled from SSF National Team pending the outcome of their investigation.

- Athletes are not allowed to have colored hair during training & competition by Singapore Silat Federation. Athlete will be asked to leave training or change hair color on the spot

- Athlete that is caught participating in illegal activities or defaming SSF will be expelled from SSF National Team & held seriously

- Physical & Verbal bullying is not acceptable. Athlete who was reported and caught will be sent for counselling, club will be informed & is not allowed to compete for 3 championships

- Athlete who do not make weight during overseas & local competition will need to reimburse SSF for the expenses

- Circulation of offensive, derogatory or sexually explicit material will be suspended for 6 months and sent for counselling

- Athlete involved in extremist will be handed over to relevant authorities & parents and club will be notified

- Only silat uniform sold by SSF is allowed to be worn by athlete for training & competition

## 6. Payment

- Once enrolled, there shall not be any refund of fees

## 7. Photography & Videography

- No videography or photography is allowed in the training hall during training without approval from High Performance Manager

## 10. Expulsion / Dismissal

- Athletes who are suspended or expelled from SSF will not be allowed to re – register as aSSF National athlete until the outcome of Investigation.

## 11. National Service (Male Athlete)

- SSF is only able to put up male athletes who have completed 1 year of National Service for sportsmen scheme

## 12. Marketing & Promotion

In relation to the marketing and promoting the national athlete whom is under the charge of Singapore Silat Federation, I hereby undertake, permit and agree with the High-Performance Manager or Marketing Manager as follows;

### 12.1 Talent Release

- 12.1.1 SSF and its assigns shall be and remain the exclusive owner of thenational athlete and its products in Singapore.
- 12.1.2 To render services as a talent/performer in any projects required by/forSSF.
- 12.1.3 To waive any right to edit or approve the use and release of the finished projects.
- 12.1.4 To attend any screen tests, wardrobe fittings, film shooting, or photographic session reasonably required by/for SSF.

- 12.1.5 To be punctual and in good performing condition for the due performance of the part prescribed as required by the relevant shoot board and schedule.
- 12.1.6 To supply personal wardrobe as required, and to observe the requirement of SSF or external companies approved by SSF to dress, style, make-up and hairstyle.
- 12.1.7 To perform as directed, to abide by all the rules and regulations set by SSF, and standby for duty from the call time until stand down.
- 12.1.8 To attend reshoot or extension of shooting time as is necessary for the successful completion of the production.
- 12.1.9 To allow the taking of still photography and video for use in relevant campaign/project or for record purpose.
- 12.1.10 To allow the use of the work in any format in connection with the specified advertising campaign/project, including what might be deemed to be misrepresentation, distortion, optical illusion, faulty reproduction, cut-down or add-on in the finished materials.
- 12.1.11 I hereby release SSF and its assigns from any claim of any kind or nature whatsoever arising from the use of My Services, including, but not limited to, those based upon "moral rights" (which to the extent such "moral rights" may not be granted are expressly waived), defamation (including libel and slander), invasion of privacy, right of publicity, copyright, or any other personal and/or property rights ("Claim") and agree that I will not now or in the future assert or maintain Claims against SSF and/or its assigns.

I undertake to keep SSF and its assigns fully indemnified in respect of all actions, proceedings, claims, demands, expenses whatsoever which may be made against or suffered or incurred by SSF in consequence of any breach by me of any of the warranties, representations or undertakings in this release.

## 12.2 Appearances/Endorsements

- 12.2.1 To allow SSF the right to liaise and deal directly with external parties should you be approached for appearance in campaigns/projects and or endorsement for any products.
- 12.2.2 To agree that all fees received during the said appearances shall be billed and paid to SSF.

12.2.3 To agree in paying forty percent (40%) of any payment or royalties received from external parties to SSF due from appearance, endorsement of such products as agreed between SSF and external parties.

12.2.4 SSF will not be taking from the national athletes for any in-kind or product sponsorship received for their appearances or endorsement.

12.2.5 SSF shall have the right to reject any request prior written notice from the external parties in featuring the national athlete should he/she have not been performing their due diligence and declining in contributions of achievements.

I agree that the terms and conditions of this Release shall be governed by the laws of Singapore.
